### **Temporary Restricted Areas EKR664 ZONE 1, EKR665 ZONE 2, EKR666 ZONE 3, EKR667 ZONE 4, EKR668 ZONE 5**

Due to police border control with drone, five Temporary Restricted Areas will be established. When activated by NOTAM no traffic permitted in the areas without prior permission from ATC Skrydstrup.

Traffic from EKTD/EKPB can contact Wing Operations Center (WOC) (who will coordinate with Skrydstrup ATC) by telephone +45 72 84 81 24 for permission to depart out of EKTD/EKPB. Minor delay up till 10 minutes may be expected for departure. After departure the pilot shall report to ATC Skrydstrup on frequency 124.105 when the relevant Restricted Area is vacated.

Traffic with destination EKTD/EKPB can contact ATC Skrydstrup on frequency 124.105 for permission to enter relevant Restricted Area. Minor delay up till 10 minutes may be expected. After landing the pilot shall report landing to ATC Skrydstrup on frequency 124.105 or by telephone.

Note: It is not Sufficient to close flight plan while airborne. An additional report of landing shall be made to ATC Skrydstrup.
